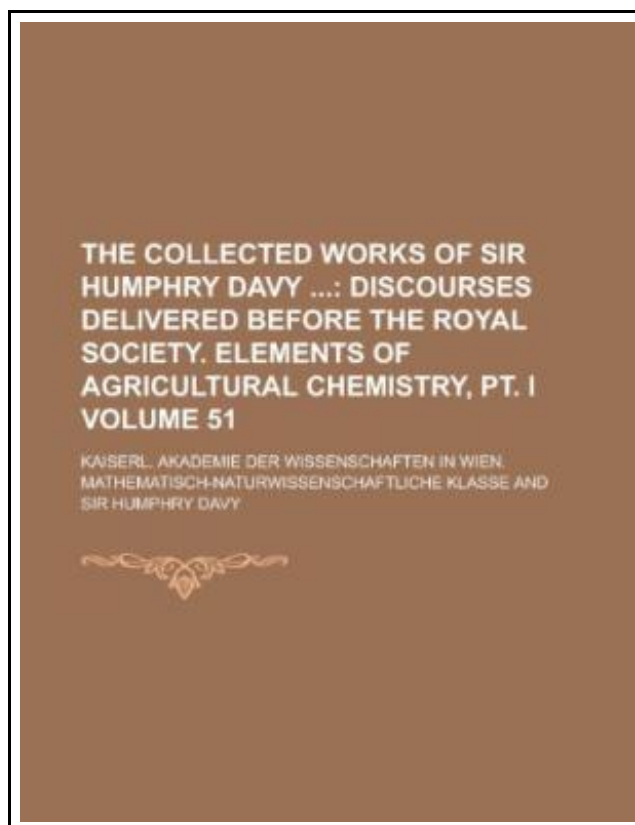

Excerpt: . . . 11 On June 1, 2009, pursuant to the Omnibus Appropriations Act of 2009 (as clarified by the Credit CARD Act of 2009) the Commission commenced rulemaking 31 proceedings on unfair or deceptive mortgage-related practices: This week, the Commission issued a notice of proposed rulemaking, seeking public comment on a proposed rule covering loan modification, foreclosure res-cue, and other mortgage assistance relief services. The rule would ban providers from collecting fees prior to delivering the promised results, prohibit misrepresentations in the marketing of these services, and require certain affirmative disclosures about the nature and terms of the service. The Commission anticipates publishing a second notice of proposed rule-making in the near future addressing mortgage advertising practices, followed by a third proposed rulemaking addressing mortgage servicing. On August 19, 2009, the Commission published in the Federal Register proposed 32 amendments to the Telemarketing Sales Rule (TSR) designed to curb deception and abuse by providers of for-profit debt relief services. The amended rule proposed by the Commission would, among other things, prohibit debt relief service providers from charging consumers a fee until they have delivered the promised results. The Commission staff is considering the public comments the agency received in response to the proposed rule and has begun drafting a final rule. The Commission, in conjunction with the Federal bank agencies, also has promulgated rules to protect the privacy of consumers sensitive information, including financial and credit report information, under the GLB Act and the FACT...
